### **Keystone Merger Town Hall #3**

#### **Association Discussion Talking Points:**

- 1. A Conference cannot determine any of the factors that shape an Association. A Conference cannot make decisions related to Association mergers or resource sharing. The Keystone Working group hopes Association leaders will begin to have those conversations (some have already begun in numerous Associations), but a Conference cannot mandate those conversations. [PNE, a Conference acting as an Association, is an exception] For more detailed information, see excerpts from the UCC Constitution and Bylaws regarding Associations at the end of this document.
- 2. What a new Keystone Conference can expect from Associations:
  - a. **Engagement** Be fully engaged and committed to a relationship with the Conference and to the Association member churches.
  - b. **On-boarding of new clergy** within the association. Set up a plan for welcome, mentoring if desired, introductions, expectations, etc.\*
  - c. **Pastoral Care of Association clergy** including visitation if in hospital, etc. if that is not already happening. \*
  - d. **Search and Call Team support**, e.g., 2-3 individuals who would be connected to the Association Executive Committee. The Exec Comm would track the Team members and work with Regional Minister to find replacements and facilitate the search and call process when necessary.
  - e. **Association President** would serve on a Presidents' Council and attend the regularly scheduled meetings.
  - f. **Provide recommendations** to the Conference for experts/experienced individuals to serve on various teams within the new Conference. For example, Associations may be asked to provide 1-2 names of people with expertise in areas such as financial consulting or conflict management. This makes the connection between the Exec Committee and the local church critical so Association leaders can tap the clergy to recommend experts/passionate people who might be open to serving on various teams at the Association, Conference, and National Church setting.

- 3. What the Conference would provide to Associations/Clergy:
  - a. Education and training perhaps part of RM role's will be trainings that currently happen for clergy, but shorter and zoom recorded, on topics of Association interest/need (possibly written materials for those without internet)
  - b. **Regular infusions of best practices** and educational events, including boundary trainings, anti-racism trainings, lay leadership trainings, etc.
  - c. Regular written communication from ECM to the Association executive committees with Conference-wide updates and ECM-specific updates (preferably monthly or bi-monthly).
  - d. **An Association Presidents' Council** that would meet on regular basis (quarterly?) to be determined by the new ECM.
  - e. Staff will resource COMs but will not be at all COM meetings
    - Fitness Reviews will likely remain with a Unified or Regional Team
    - Some associations (PCC) appreciate a separate MID Assessment Team so this will be up for further discussion over time
  - f. **Support when requested**, such as conflict issues or leadership coaching there will be someone to assist but it may not be a staff member (will likely be specialized team members).
  - g. **Search and Call** will be overseen by staff, but staff will be working with a Search and Call team made up of members from various associations.
  - h. **Reliable (scheduled), clear communication** to clergy specifically *with the assumption that* clergy will pass on information to their congregations.
  - i. Steady, reliable **social media usage and videos** that allow for conference staff to be present with multiple settings.

## **United Church of Christ Constitution Article III: Covenantal Relationships**

Within the United Church of Christ, the various expressions of the church relate to each other in a covenantal manner. Each expression of the Church has responsibilities and rights in relation to the others, to the end that the whole Church will seek God's will and be faithful to God's mission. Decisions are made in consultation and collaboration among the various parts of the structure. As members of the Body of Christ, each expression of the Church is called to honor and respect the work and ministry of each other part. Each expression of the Church listens, hears, and carefully considers the advice, counsel, and requests of others. In this covenant, the various expressions of the United Church of Christ seek to walk together in all God's ways.

#### **Article IX: Associations and Conferences**

Associations and Conferences are bodies organized on a territorial basis to perform functions in accordance with the provisions of the Constitution and the Bylaws of the United Church of Christ.

**Associations:** An Association is that body within a Conference of the United Church of Christ which is composed of all Local Churches in a geographical area, all Ordained Ministers holding Standing or Ordained Ministerial Partner Standing therein, all Commissioned Ministers and Licensed Ministers in that Association. The boundaries of any new Association, or any adjustment of boundaries between Associations, shall be determined by the Associations concerned with the approval of the Conference or Conferences involved. The standing of an Association as a body of the United Church of Christ is determined by the Conference in which it is located. An Association is that body which determines, confers, and certifies to the standing of the Local Churches of the United Church of Christ within its area. An Association is that body which grants authorization that is required for various forms of ministry in and on behalf of the Church. Such authorization is granted through the rite of ordination, through commissioning, licensing, granting either Ordained Ministerial Standing or Ordained Ministerial Partner Standing and other acts of authorization. Such authorization may be terminated by the Association. An Association may retain or secure its own charter, and adopt its own constitution, bylaws and other rules which it deems essential to its own welfare and not inconsistent with this Constitution and the Bylaws of the United Church of Christ. An Association is related to the General Synod through its Conference. When an Association meets, its voting membership includes the lay delegates selected by and representing the Local Churches of that Association, all Ordained Ministers holding Standing or Ordained Ministerial Partner Standing therein, all Commissioned Ministers and Licensed Ministers of that Association, and such additional members as may be specified by the Association in its constitution or bylaws. Meetings of the Association are held annually and at such other times as may be necessary for the discharge of its responsibilities.

## **United Church of Christ Bylaws Article II**

- An Association elects officers and elects or appoints such committees as it deems necessary for the transaction of its business and the correlation of its work with that of the Conference and the General Synod.
- An Association determines its own method for securing financial support.
- An Association is concerned with the welfare of all Local Churches within its boundaries.
- An Association seeks ways and means to assist Local Churches when they are undergoing unusual difficulties requiring help beyond their own resources.
- An Association offers encouragement, guidance, and assistance in the organization of new Local Churches.
- An Association, with the counsel of the Conference, receives Local Churches into the United Church of Christ.
- An Association covenants with members of the United Church of Christ within that
  Association as together they discern God's call to authorized ministry and prepare for
  ordination, commissioning or licensing.
- An Association ordains, commissions, and licenses qualified candidates; grants standing as a covenantal relationship with Ordained Ministers, Licensed Ministers, Commissioned Ministers, and persons with Ordained Ministerial Partner Standing; certifies to, transfers, and terminates Ordained Ministerial Standing, Ordained Ministerial Partner Standing, commissioned ministerial standing and licenses; installs Ordained Ministers and persons with Ordained Ministerial Partner Standing; covenants with Licensed Ministers, Commissioned Ministers, and the Local Churches to which they are called; grants Privilege of Call and Leaves of Absence; reviews and ecclesiastically oversees Ordained, Commissioned, and Licensed Ministers and persons with Ordained Ministerial Partner Standing; and verifies that an Ordained Ministerial Partner has demonstrated knowledge of, and appreciation for, the history, polity, and practices of the United Church of Christ.
- An Association receives and acts upon business referred to it by its Local Churches, its Conference, the General Synod, and other bodies. An Association may petition and overture its Conference or the General Synod.
